


Illinois Congressional District 14

Encompasses parts of McHenry, Lake, Kane, Dekalb, Dupage, Will, and Kendall Counties, US Congress District 14 begins at the northwest corner of McHenry County, thence east along the Illinois / Wisconsin border to the Zion Twp border in Lake County, thence south along the Zion / Newport Twp border to 9th St, thence west along 9th St for approximately 90 feet, thence south for approximately 1630 feet, thence northwest for approximately 150 feet, thence south for approximately 6400 feet to W. 21st St, thence east along W. 21st St to the Benton Twp border, thence south along the Benton / Newport Twp border and continuing south along the Warren / Waukegan Twp border to W. Blanchard Rd, thence west along W. Blanchard Rd to N. Delaney Rd, thence continuing west along W. Blanchard Rd (extended) for approximately 4600 feet to the Soo (Amtrak) rail line, thence southeast and south along the Soo (Amtrak) rail line to N. Skokie Hwy, thence southeast along N. Skokie Hwy to N. Delaney Rd, thence south along N. Delaney Rd to Grandville Av, thence east along Grandville Av to Blackburn St, thence south along Blackburn St to Grandview Av, thence east along Grandview Av to Ferndale St, thence north along Ferndale St to Grandville Av, thence east along Grandville Av to Estes Av, thence south along Estes Av to Grandview Av, thence east along Grandview Av to N. Skokie Hwy, thence south along N. Skokie Hwy to Washington St, thence west along Washington St to S. Oplaine Rd, thence south along S. Oplaine Rd to W. Belvidere Rd, thence west along W. Belvidere Rd to Milwaukee Av, thence northeast along Milwaukee Av to Gages Lake Rd, thence west along Gages Lake Rd to N. Hunt Club Rd, thence north along N. Hunt Club Rd to Grand Av, thence west along Grand Av to N. Hutchins Rd, thence north along N. Hutchins Rd to N. Grandwood Dr, thence west along N. Grandwood Dr for approximately 120 feet, thence north for approximately 260 feet to the Old Mill Creek municipal border, thence west along the Old Mill Creek municipal border for approximately 2715 feet, thence south for approximately 1330 feet to W. Grier Rd, thence west for approximately 1800 feet to N. US Hwy 45, thence north along N. US Hwy 45 to W. Sand Lake Rd, thence west along W. Sand Lake Rd for approximately 3930 feet, thence north for approximately 2610 feet, thence west for approximately 1370 feet to N. Beck Rd, thence north along N. Beck Rd for approximately 100 feet to the south border of Section 35, T46N, R10E (3rd principal meridian),

thence west along the south border of Section 35, T46N, R10E (3rd principal meridian) for approximately 2650 feet,
thence north for approximately 1310 feet,
thence west for approximately 1690 feet to the intersection of Hickory Dr and Fairfield Rd,
thence northwest for approximately 120 feet,
thence west for approximately 90 feet,
thence south for approximately 80 feet,
thence west southwest for approximately 425 feet,
thence south for approximately 900 feet,
thence east for approximately 100 feet,
thence south for approximately 300 feet to W. Grand Av,
thence southeast along W. Grand Av for approximately 230 feet,
thence southwest for approximately 80 feet,
thence west northwest and west approximately 100 feet south of and parallel to W. Grand Av and continuing to run parallel for approximately 3240 feet,
thence north for approximately 100 feet to W. Grand Av,
thence west along W. Grand Av to N. Deep Lake Rd,
thence north along N. Deep Lake Rd for approximately 580 feet,
thence west northwest and southwest across Deep Lake for approximately 4000 feet to the west shoreline of Deep Lake at a point approximately 290 feet north of the terminus of Shoshoni Trail,
thence southwest for approximately 120 feet,
thence north for approximately 50 feet,
thence west southwest for approximately 810 feet to N. Milwaukee Av,
thence north along N. Milwaukee Av to Lake Av,
thence west along Lake Av to Cedar Av,
thence southwest along Cedar Av to W. Grand Av,
thence west along W. Grand Av to N. IL Rt 59,
thence northeast along N. IL Rt 59 to W. Columbia Bay Rd,
thence west along W. Columbia Bay Rd to the intersection of N. Columbia Bay Rd,
thence west southwest for approximately 265 feet to the Fox Lake shoreline,
thence west across Fox Lake to the Antioch Twp border,
thence south along the Antioch / Lake Villa Twp border to the northeast corner of Grant Twp,
thence west along the Antioch / Grant Twp border to the McHenry County border,
thence south along the McHenry / Lake County border to the southwest corner of Grant Twp in Lake County,
thence east along the Grant / Wauconda Twp border to Belvidere Rd,
thence east northeast for approximately 4015 feet to Wilson Rd at a point approximately 400 feet north of the Wauconda Twp border,
thence south along Wilson Rd to the Fremont Twp border,
thence continuing south along the Fremont / Wauconda Twp border to W. Chardon Rd,
thence east along for approximately 470 feet,
thence northeast for approximately 45 feet,
thence east for approximately 210 feet,
thence south for approximately 45 feet to W. Chardon Rd,
thence east along W. Chardon Rd W. IL Rt 60,
thence southeast along W. IL Rt 60 to W. Peterson Rd,
thence northeast and east along W. Peterson Rd to the east border of Section 10, T44N, R10E (3rd principal meridian),

thence south along the east border of Section 10, T44N, R10E (3rd principal meridian) to the southeast corner of Section 10, T44N, R10E (3rd principal meridian),
thence east northeast for approximately 1730 feet to the terminus of W. Winchester Rd,
thence continuing east northeast along W. Winchester Rd to Ivanhoe Rd,
thence southwest along Ivanhoe Rd to the south border of Section 14, T44N, R10E (3rd principal meridian),
thence east along the south border of Section 14, T44N, R10E (3rd principal meridian) for approximately 475 feet,
thence south for approximately 2625 feet to W. Maple Av,
thence west along W. Maple Av to the west border of Section 23, T44N, R10E (3rd principal meridian),
thence south along the west border of Section 23, T44N, R10E (3rd principal meridian) for approximately 1270 feet,
thence east for approximately 1570 feet to N. IL Rt 83,
thence southeast along N. IL Rt 83 for approximately 4580 feet,
thence south for approximately 5100 feet to N. Midlothian Rd,
thence southwest along N. Midlothian Rd to the Ela Twp border,
thence west along the Ela / Fremont Twp border and continuing west along the Wauconda / Cuba Twp border and continuing west along the Nunda / Algonquin Twp border to the east shoreline of Silver Lake,
thence and northwest along the Silver Lake shoreline to the Nunda / Algonquin Twp border,
thence west along the Algonquin / Nunda Twp border to the southeast corner of Dorr Twp,
thence south to the Algonquin Twp border,
thence continuing south along the Algonquin / Grafton Twp border to the Kane County border,
thence west along the Kane / McHenry County border to the northwest corner of Section 2, T42N, R8E (3rd principal meridian),
thence south along the west borders of Sections 2, 11, 14, 23, and 26 of T42N, R8E (3rd principal meridian) to the southwest corner of Section 26, T42N, R8E (3rd principal meridian),
thence west along the south border of Section 27, T42N, R8E (3rd principal meridian) to the northwest corner of E ½ of Section 34, T42N, R8E (3rd principal meridian),
thence south along the west border of E ½ of Section 34, T42N, R8E (3rd principal meridian) to the Plato Twp border,
thence east along the Plato / Rutland Twp border to Coombs Rd,
thence south along Coombs Rd to Plank Rd,
thence continuing south along the Elgin / Plato Twp border and continuing south along the Campton / St. Charles Twp border to Dean St,
thence southeast along Dean St to the Chicago and Northwestern rail line,
thence east along the Chicago and Northwestern rail line to N. 2nd Av,
thence south along N. 2nd Av to E. Main St,
thence east along E. Main St to N. 6th Av,
thence north along N. 6th Av to Cedar Av,
thence east along Cedar Av to N. 7th Av,
thence north along N. 7th Av to State Av,
thence northeast along State Av to N. 9th Av,
thence south along N. 9th Av for approximately 190 feet,
thence east for approximately 165 feet to Cedar Av,
thence east along Cedar Av to E. Main St,
thence east along E. Main St to Tyler Rd,
thence south along Tyler Rd to S. Tyler Rd,

thence continuing south along S. Tyler Rd to Moore Av,
thence east along Moore Av (extended) for approximately 2200 feet to the intersection of Cumberland Green Dr and Cumberland Green Pky,
thence east along Cumberland Green Pky to Kirk Rd,
thence south along Kirk Rd to the Geneva Twp border,
thence east along the Geneva / St. Charles Twp border to the Dupage County border,
thence south along the Dupage / Kane County border to the Chicago and Northwestern rail line,
thence east along the Chicago and Northwestern rail line to the Burlington Northern & Santa Fe rail line,
thence west along the Burlington Northern & Santa Fe rail line to Wood St,
thence south along Wood St to W. Geneva St,
thence continuing south, west and south along Wood St to W. Blair St,
thence west along W. Blair St to its terminus,
thence north for approximately 340 feet to Ann St,
thence west along Ann St to the Elgin Joliet and Eastern rail line,
thence south along the Elgin Joliet and Eastern rail line to E. Roosevelt Rd,
thence southeast along E. Roosevelt Rd to Bishop St,
thence north along Bishop St to Glen Av,
thence east along Glen Av to S. Neltnor Blvd,
thence south along S. Neltnor Blvd to Sarana Av,
thence east and south along Sarana Av to E. Roosevelt Rd,
thence southeast along E. Roosevelt Rd to Indian Knoll St,
thence south along Indian Knoll St to its terminus,
thence continuing south along Indian Knoll St (extended) to Purnell Rd,
thence southeast along Purnell Rd to Winfield Rd,
thence south along Winfield Rd to Butterfield Rd,
thence east along Butterfield Rd to the west border of Section 25, T39N, R9E (3rd principal meridian),
thence south along the west borders of Sections 25 and 36, T39N, R9E (3rd principal meridian) to the Warrenville municipal border,
thence east and south along the Warrenville municipal border to Greenview Av,
thence west along Greenview Av to Winfield Rd,
thence south along Winfield Rd to Warrenville Rd,
thence west along Warrenville Rd to Warren Av,
thence south along Warren Av to Rogers Av,
thence east along Rogers Av to River Rd,
thence south along River Rd to the Naperville Twp border,
thence west along the Naperville / Winfield Twp border and continuing west along the Aurora / Batavia Twp border to Ginger Woods Dr,
thence west northwest for approximately 660 feet to the intersection of Ginger Woods Pky and Ginger Woods Dr,
thence west southwest for approximately 780 feet to the Aurora Twp border,
thence west along the Aurora / Batavia Twp border to the northwest corner of Aurora Twp,
thence south along the Aurora / Sugar Grove Twp border to the Kendall County border,
thence west along the Kendall / Kane County border to Prescott Dr,
thence south along Prescott Dr to Concord Dr,
thence west along Concord Dr to Prarie Crossing Dr,
thence south along Prarie Crossing Dr to Manchester Dr,
thence continuing south along Prarie Crossing Dr (extended) for approximately 80 feet,
thence east for approximately 800 feet,

thence northeast for approximately 720 feet,
thence south for approximately 390 feet,
thence east for approximately 360 feet,
thence south for approximately 670 feet,
thence west for approximately 140 feet,
thence south for approximately 140 feet to Galena Rd,
thence northeast along Galena Rd to S. Concord Dr,
thence southwest and south along S. Concord Dr to Grape Vine Tr,
thence west and south along Grape Vine Tr to Tuscany Tr,
thence east along Tuscany Tr to Orchard Rd,
thence north along Orchard Rd for approximately 930 feet,
thence east for approximately 1550 feet,
thence south for approximately 1010 feet,
thence east for approximately 1060 feet to the Oswego Twp border,
thence south along the Oswego / Bristol Twp border for approximately 1560 feet,
thence east for approximately 4000 feet to the intersection of Laurie Ln and Dolores St,
thence south for approximately 100 feet,
thence east for approximately 250 feet to State Rt 31,
thence south along State Rt 31 for approximately 150 feet,
thence east for approximately 1650 feet to the west bank of the Fox River,
thence north along the west bank of the Fox River for approximately 825 feet,
thence east for approximately 1300 feet to Ashlawn Av,
thence north along Ashlawn Av to Circle Dr W,
thence northwest along Circle Dr W to Old Post Rd,
thence northeast along Old Post Rd to Field Point Rd,
thence east along Field Point Rd to Boulder Hills Pass,
thence north along Boulder Hills Pass to Old Post Rd,
thence east along Old Post Rd to Wabansee Creek,
thence northeast along Waubensee Creek to Douglas Rd,
thence south along Douglas Rd to US 34,
thence northeast along US 34 to Heritage Dr,
thence north northeast for approximately 300 feet,
thence northeast for approximately 1800 feet parallel to US 34,
thence south for approximately 50 feet to US 34,
thence northeast along US 34 to the northeast corner of Section 10, T37N, R8E (3rd principal meridian),
thence south southeast for approximately 1800 feet to a point approximately 45 feet west of Bohannon Circle,
thence south southwest and south for approximately 570 feet to 5th St,
thence southeast along 5th St to Wolfs Crossing Rd,
thence east along Wolfs Crossing Rd to Harvey Rd,
thence south along Harvey Rd for approximately 45 feet,
thence east along Wolfs Crossing Rd to the Will County border,
thence north along the Will / Kendall County border to the Dupage County border,
thence east along the Will / Dupage County border to S. IL Rt 59,
thence south along S. IL Rt 59 to W. 95th St,
thence east along W. 95th St to Book Rd,
thence north along Book Rd to the Dupage County border,
thence east along the Dupage / Will County border to Modaff Rd,

thence south along Modaff Rd for approximately 725 feet,
thence continuing south for approximately 740 feet to Danbury Dr,
thence south southeast for approximately 480 feet to Avena Circle,
thence south for approximately 485 feet to Senna Ct,
thence west along Senna Ct to Modaff Rd,
thence south along Modaff Rd for approximately 490 feet,
thence east for approximately 60 feet,
thence south for approximately 50 feet,
thence east for approximately 270 feet,
thence south for approximately 260 feet to Haddassah Dr,
thence west for approximately 280 feet,
thence south for approximately 2040 feet to the intersection of Knoch Knolls Rd and Modaff Rd,
thence continuing south for approximately 1740 feet to the West Branch Dupage River,
thence south and southwest along the West Branch Dupage River to Plainfield-Naperville Rd,
thence south along Plainfield-Naperville Rd to Naperville Rd,
thence continuing south along Naperville Rd to a point approximately 110 feet north of W. 111th St,
thence southeast for approximately 110 feet to the intersection of W. 111th St and Essington Rd,
thence south along Essington Rd to the Plainfield Twp border,
thence east along the Plainfield / Wheatland Twp border to I-55,
thence southeast and south along I-55 to W. Lockport Rd,
thence west along W. Lockport Rd to the Elgin Joliet and Eastern rail line,
thence southwest along the Elgin Joliet and Eastern rail line to W. Renwick Rd,
thence west along W. Renwick Rd and continuing west along W. Wheeler Rd to Schlapp Rd,
thence south along Schlapp Rd and Schlapp Rd (extended) to the Seward Twp border,
thence east along the Seward / Na Au Say Twp border to the Will County border,
thence south along the Will / Kendall County border to Baltz Rd,
thence east along Baltz Rd to W. Jefferson St,
thence continuing east along W. Jefferson St to IL Rt 59,
thence south along IL Rt 59 to Westshore Dr,
thence southwest along Westshore Dr to S. Raven Rd,
thence south along S. Raven Rd to Valencia Dr,
thence southeast and southwest along Valencia Dr to S. Raven Rd,
thence south along S. Raven Rd to Seil Rd,
thence southwest and southeast along Seil Rd to W. Seil Rd,
thence east along W. Seil Rd to SW Frontage Rd,
thence south southeast for approximately 300 feet to I-55,
thence south along I-55 to the Channahon Twp border,
thence west along the Channahon / Troy Twp border to the Kendall County border,
thence continuing west along the Kendall / Grundy County border to the southwest corner of Kendall County,
thence north along the Kendall / Lasalle County border to the southeast corner of Dekalb County,
thence west along the Dekalb / Lasalle County border to the southwest corner of Somonauk Twp in Dekalb County,
thence north along the Somonauk / Victor Twp border to the Squaw Grove twp border,
thence west along the Squaw Grove / Victor Twp border to the southwest corner of Squaw Grove Twp,
thence north along the Squaw Grove / Clinton Twp border and continuing north along the Afton / Pierce Twp border, and continuing north along the Dekalb / Cortland Twp border, and continuing north along the Sycamore / Mayfield Twp border to N. Grove Rd,

thence east along N. Grove Rd to a point approximately 90 feet west of Frantum Rd,
thence south for approximately 1460 feet parallel to Frantum Rd,
thence east for approximately 1390 feet,
thence south for approximately 1020 feet to the terminus of Millbridge Dr,
thence east along Millbridge Dr to Ward Blvd,
thence south along Ward Blvd to Peace Rd,
thence east along Peace Rd to IL Rt 23,
thence north along IL Rt 23 to Northgate Dr,
thence east along Northgate Dr for approximately 275 feet,
thence north for approximately 540 feet,
thence east for approximately 335 feet,
thence south for approximately 490 feet,
thence east for approximately 330 feet,
thence north for approximately 435 feet,
thence east for approximately 710 feet to Luther Lowell Ln,
thence south along Luther Lowell Ln for approximately 435 feet,
thence east for approximately 325 feet,
thence north along Pioneer Way (extended) and Pioneer Way for approximately 600 feet,
thence east for approximately 300 feet to Surrey St,
thence southeast for approximately 480 feet to Celerity Dr,
thence northeast along Celerity Dr for approximately 160 feet,
thence southeast for approximately 1200 feet to Plank Rd,
thence southwest along Plank Rd to Lindgren Rd,
thence east along Lindren Rd to the Kane County border,
thence north, east and north along the Kane / Dekalb County border to the McHenry County border,
thence west along the McHenry / Dekalb County border to the Boone County border,
thence north along the Boone / McHenry County border to the point of beginning.
