

COOK COUNTY JUDICIAL CIRCUIT, SUBCIRCUIT NO. 8

Beginning at the Intersection of the Lake Michigan shore and Thorndale Avenue as extended, in Chicago (5900 N.),
Thence west on Thorndale Avenue as extended and Thorndale Avenue to Kenmore Avenue,
Thence north on Kenmore Avenue to Glenlake Avenue,
Thence west on Glenlake Avenue to Winthrop Avenue,
Thence north on Winthrop Avenue to Sheridan Road (also known as Devon Ave.),
Thence west on Sheridan Road to the CTA Rapid Transit,
Thence northwest on the CTA Rapid Transit to Arthur Avenue as extended,
Thence west on Arthur Avenue as extended and Arthur Avenue to Glenwood Avenue,
Thence south on Glenwood Avenue to Arthur Avenue,
Thence west on Arthur Avenue to Ashland Avenue,
Thence south on Ashland Avenue and continuing south on Clark Street to Peterson Avenue,
Thence west on Peterson Avenue to Western Avenue,
Thence south on Western Avenue to Berwyn Avenue,
Thence east on Berwyn Avenue to Hoyne Avenue,
Thence south on Hoyne Avenue to Foster Avenue,
Thence east on Foster Avenue to Winchester Avenue,
Thence south on Winchester Avenue to Winnemac Avenue,
Thence east on Winnemac Avenue to Ravenswood Avenue,
Thence north on Ravenswood Avenue to Foster Avenue,
Thence east on Foster Avenue to Clark Street,
Thence generally south on Clark Street to Wilson Avenue,
Thence west on Wilson Avenue to Ashland Avenue,
Thence south on Ashland Avenue to Roscoe Street,
Thence west on Roscoe Street to Ravenswood Avenue,
Thence south Ravenswood Avenue to Belmont Avenue,
Thence east on Belmont Avenue to Ashland Avenue,
Thence south on Ashland Avenue to Fullerton Avenue,
Thence west on Fullerton Avenue to the North Branch of the Chicago River,
Thence southeast and south along the North Branch of the Chicago River to Division Street,
Thence west on Division Street to Elston Avenue,

Thence southeast and south on Elston Avenue to Augusta Boulevard,
Thence west on Augusta Boulevard to Racine Avenue,
Thence south on Racine Avenue to Chicago Avenue,
Thence east on Chicago Avenue to Halsted Street,
Thence south on Halsted Street to Kinzie Street,
Thence east on Kinzie Street to the North Branch of the Chicago River,
Thence south on the North Branch of the Chicago River to the South Branch
of the Chicago River,
Thence southeast, south and southwest along the South Branch of the
Chicago River to I-90/94 (the Dan Ryan Expressway),
Thence southeast on I-90/94 to Stewart Avenue (at 26th St.),
Thence south on Stewart Avenue to 27th Street,
Thence east on 27th Street to Princeton Avenue,
Thence south on Princeton Avenue to 31st Street,
Thence east on 31st Street to the Chicago, Rock Island & Pacific R.R.,
Thence north on the Chicago, Rock Island & Pacific R.R. to 26th Street,
Thence east on 26th Street as extended directly east from Dr .Martin Luther
King Drive to the Lake Michigan shore,
Thence northwest along the Lake Michigan shore to the place of beginning.
