



Representative District 2 shall include that part of Illinois beginning at the intersection of South Homan Ave. and West Cermak Rd. in the City of Chicago in Cook County, thence east to South Marshall Blvd., thence north to West 19<sup>th</sup> St., thence east to South California Ave., thence south to West 21<sup>st</sup> St., thence east to the Chicago Burlington and Quincy RR, thence north and northeast following the Chicago Burlington and Quincy RR to West 19<sup>th</sup> St., thence east to South Western Ave., thence north to West 18<sup>th</sup> Pl., thence east to South Oakley Ave., thence north to West 18<sup>th</sup> St., thence west to South Western Ave., thence north to West 16<sup>th</sup> St., thence east to South Carpenter St., thence south to West 18<sup>th</sup> St., thence east to South Sangamon St., thence south to the Chicago River South Branch, thence northeast following the Chicago River South Branch to South Halsted St., thence south approximately 1,388 feet following South Halsted St., thence southwest approximately 526 feet, thence south approximately 808 feet to the district boundary, thence east approximately 827 feet following the district boundary to South Emerald Ave. extended, thence south to West 25<sup>th</sup> Pl., thence east to South Lowe Ave., thence southeast to West 26<sup>th</sup> St., thence east to South Lowe Ave., thence south to West 35<sup>th</sup> St., thence east to South Parnell Ave., thence south to West Pershing Rd., thence west to South Morgan St., thence north to West 38<sup>th</sup> St., thence west and northwest following West 38<sup>th</sup> St. to the Baltimore and Ohio RR, thence southwest following the Baltimore and Ohio RR to South Racine Ave., thence south to West 42<sup>nd</sup> Pl., thence west to South Loomis St., thence north to West 42<sup>nd</sup> St., thence west to South Ashland Ave., thence south to West 42<sup>nd</sup> St., thence west to South Marshfield Ave., thence south to West 43<sup>rd</sup> St., thence west to South Wood St., thence south to West 45<sup>th</sup> St., thence west to the CSX RR and Norfolk Southern Railway,

thence north and northwest following the CSX RR and Norfolk Southern Railway to South Western Ave.,  
thence north to the Gulf Mobile and Ohio RR,  
thence northeast following the Gulf Mobile and Ohio RR to West 35<sup>th</sup> Pl.,  
thence west to South Bell Ave.,  
thence north to West 34<sup>th</sup> St.,  
thence west to South Oakley Ave.,  
thence north and northwest following South Oakley Ave. to West Bross Ave.,  
thence southwest to South Western Ave.,  
thence north approximately 3,089 feet following South Western Ave. to the district boundary,  
thence northwest approximately 1,428 feet following the district boundary to South Oakley Ave.,  
thence north to the Chicago Burlington and Quincy RR,  
thence west following the Chicago Burlington and Quincy RR to South Western Ave.,  
thence north to West 26<sup>th</sup> St.,  
thence west to the Gulf Mobile and Ohio RR,  
thence west and southwest following the Gulf Mobile and Ohio RR to South Whipple St.,  
thence north to West 26<sup>th</sup> St.,  
thence west to South Homan Ave.,  
thence north to the place of beginning.
