

Representative District 37 shall include that part of Illinois including those parts of Orland, Bremen, and Rich Twps. in Cook County and part of Frankfort Twp. in Will County beginning at the intersection of South Wolf Rd. and 135th St. in Orland Twp., thence east to the east boundary of the Orland Park Corp. limits, thence south to 88th Ave., thence continuing south following 88th Ave. to West 151st St., thence east to South 80th Ave., thence south to Wheeler Dr., thence east, southeast and east following Wheeler Dr. to the Bremen Twp. line (Il. Rt. 43), thence north following Il Rt. 43 to the Oak Forest Corp. limits, thence east, south, east, south and east following the Oak Forest Corp. limits to Oak Park Ave., thence north to the Oak Forest Corp. limits, thence east and north following the Oak Forest Corp. limits to 157th Pl., thence east to Pine Rd., thence north to Victoria Dr., thence east to Central Ave., thence north to 151st St., thence east to Laramie Ave., thence south to 154th St., thence east to LeClaire Ave., thence south to US Hwy. 6, thence east approximately 12,888 feet following US Hwy. 6 to the district boundary, thence south approximately 7,787 feet following the district boundary to Henry St., thence southwest to Craig Dr., thence south approximately 6,036 feet following Craig Dr. and Craig Dr. extended to the district boundary, thence southwest approximately 667 feet following the district boundary, thence south approximately 416 feet following the district boundary, thence southeast approximately 1,216 feet following the district boundary to I-57, thence southwest following I-57 to Forest Ave., thence north to the Oak Forest Corp. limits, thence west approximately 844 feet following the Oak Forest Corp. limits, thence south approximately 688 feet following the Oak Forest Corp. limits to the district boundary, thence west approximately 1,447 feet following the district boundary to the Oak Forest Corp. limits, thence west approximately 277 feet following the Oak Forest Corp. limits to the district boundary, thence west approximately 758 feet following the district boundary to the Oak Forest Corp. limits, thence continuing west, northwest and west following the Oak Forest Corp. limits to Lockwood Ave., thence southwest to Martha Ln., thence west to Judy Ct.,

thence south and east following Judy Ct. to Lockwood Ave.,
thence southwest to Jessica Dr.,
thence northwest to Bonnie Trl.,
thence north, northwest, west and southwest following Bonnie Trl. to Jessica Dr.,
thence northwest to Central Ave.,
thence south to 177th St.,
thence east to Central Ave.,
thence south to the Bremen Twp. line (183rd St.),
thence west, northwest and west following the Bremen Twp. line to South Ridgeland Ave. (Rich Twp.),
thence south to Vollmer Rd.,
thence west to the Frankfort Twp. line in Will County (Il Rt. 43),
thence south to the Old Plank Road Trl.,
thence west following Old Plank Road Trl. extended to South 78th Ave.,
thence north to North Ave.,
thence west to the west boundary of the Frankfort Square Corp. limits,
thence north to West St. Francis Rd.,
thence west to 88th Ave.,
thence north to the Chicago Rock Island and Pacific RR,
thence northeast following the Chicago Rock Island and Pacific RR to 183rd St. (Orland Park Twp.),
thence west to the west boundary of the Tinley Park Corp. limits,
thence north to 92nd Ave.,
thence continuing north following 92nd Ave extended to 175th St.,
thence west to Cambridge Pl.,
thence north to Walnut Ln.,
thence west to Briar Dr.,
thence north to 173rd Pl.,
thence west to South 94th Ave.,
thence north to 171st St.,
thence west to US Hwy. 45,
thence north approximately 7,618 feet following US Hwy. 45 to the district boundary,
thence west approximately 1,934 feet following the district boundary to South 97th Ave.,
thence north to Hummingbird Hill Dr.,
thence west to Chickadee Dr.,
thence south approximately 350 feet following Chickadee Dr. to the district boundary,
thence west approximately 386 feet following the district boundary,
thence north approximately 2,366 feet following the district boundary to the Orland Park Corp. limits,
thence north to US Hwy. 6,
thence west following US Hwy. 6 to South Ravinia Ave.,
thence northerly to Constitution Dr.,
thence southwest and west following Constitution Dr. to Centennial Dr.,
thence north and northeast following Centennial Dr. to West Ave.,
thence north to El Cameno Re'al Dr.,

thence east approximately 309 feet following El Cameno Re'al Dr to the district boundary,
thence northeast approximately 991 feet following the district boundary to Francesca Ct.,
thence west to West Ave.,
thence north to West 151st St.,
thence west approximately 7,147 feet following West 151st St. to the district boundary,
thence north approximately 14,504 feet following the district boundary to Il. Rt. 7,
thence west following Il Rt. 7 to Creek Crossing Dr.,
thence northeast to Stonegate Ln.,
thence northwest to Kingswood Dr.,
thence east to Creek Crossing Dr.,
thence north to 139th St.,
thence east to South Wolf Rd.,
thence north to the place of beginning.
