

Representative District 43 shall include that part of Illinois including those parts of Dundee and Elgin Twps. in Kane County and Hanover Twp. in Cook County beginning at the intersection of Il. Rt. 25 and the Dundee Twp. north line in Kane County, thence east, north, east and south following the Dundee Twp. line to I-90 (Hanover Twp. in Cook County),
