

Representative District 44 shall include that part of Illinois including those parts of Schaumburg and Hanover Twps. in Cook County beginning at the intersection of West Central Rd. and North Roselle Rd. in Schaumburg Twp,
thence south to West Golf Rd.,
thence west to Evanston St. extended,
thence south to Il. Rt. 72,
thence northwest following Il Rt. 72 to Grand Canyon Pky.,
thence southwest, south and southwest following Grand Canyon Pky. to Bode Rd.,
thence west to North Salem Dr.,
thence south to Parker Dr.,
thence west to Rugby Pl. extended,
thence north to Bode Rd.,
thence west to Downey St.,
thence northwest to West Hundley St.,
thence west to North Hundley St.,
thence north to Hundley Way,
thence west to Bode Rd.,
thence north to the Hoffman Estates Corp. limits,
thence north and west following the Hoffman Estates Corp. limits to Harmon Blvd.,
thence southwest to Bode Rd.,
thence west and southwest following Bode Rd. to Primrose Ln.,
thence south, east, southeast and east following Primrose Ln. to North Walnut Ln.,
thence south and southwest following North Walnut Ln. to Skyvue Ln.,
thence northwest and northeast following Skyvue Ln. to Brent Ct. extended,
thence west following Brent Ct. extended to Brent Ct.,
thence continuing west following Brent Ct. to Knollwood Dr.,
thence southerly to West Weathersfield Way,
thence east to Kensington Ln.,
thence south to the Hanover Park Corp. limits,
thence east approximately 5,009 feet following the Hanover Park Corp. limits,
thence south approximately 7,195 feet following the Hanover Park Corp. limits to the district boundary,
thence east approximately 2,698 feet following the district boundary,
thence south approximately 278 feet following the district boundary to the Hanover Park Corp. limits,
thence south to West Wise Rd.,
thence east to the Schaumburg Corp. limits,
thence south and east following the Schaumburg Corp. limits to Springsouth Rd.,
thence south to Valleyview Dr.,
thence west to Fairlane Dr.,
thence south and southeast following Fairlane Dr. to Crest Ave.,
thence northeast to the Schaumburg Corp. limits,
thence southeast approximately 1,702 feet following the Schaumburg Corp. limits to the district boundary,
thence south approximately 175 feet following the district boundary to West Irving Park Rd.,

thence southeast to Springsguth Rd.,
thence south approximately 6,650 feet following Springsguth Rd.,
thence southeast approximately 228 feet following Springsguth Rd. to the district boundary,
thence south approximately 869 following the district boundary,
thence east approximately 1,562 feet following the district boundary to the Schaumburg Corp. limits,
thence south to the Milwaukee RR,
thence west and southwest following the Milwaukee RR to the Hanover Twp. line,
thence continuing west to Devon Ave. (Hanover Twp. line),
thence west and south following Devon Ave. to East Devon Ave.,
thence west, northwest and southwest following East Devon Ave. to the Hanover Park Corp. limits,
thence north to the Streamwood Corp. limits (Metra Soo RR),
thence northwest following the Streamwood Corp. limits (Metra Soo RR) to South Prospect Ave.,
thence north to North Prospect Ave.,
thence continuing north following North Prospect Ave. to East Lake St.,
thence northeast to the Streamwood Corp. limits,
thence north, west and southwest following the Streamwood Corp. limits to West Lake St.,
thence northwest and west following West Lake St. to the Bartlett Corp. limits,
thence continuing northwest approximately 340 feet to the Bartlett Corp. limits,
thence northeast and east following the Bartlett Corp. limits to Will Scarlett Ln.,
thence northeasterly to Robin Hood Dr.,
thence northwest to Sherwood Rd.,
thence northeast to Nottingham Ln.,
thence west and northwest following Nottingham Ln. to Greenwood Rd.,
thence southwest to Robin Hood Dr.,
thence northwest to King Arthur Ct.,
thence northeast to Nottingham Ln.,
thence northwest to the Elgin Joliet and Eastern Railway,
thence northeast following the Elgin Joliet and Eastern Railway to East Chicago St.,
thence northwest to Rohrssen Rd.,
thence northwest to the Poplar Creek,
thence northwest following the Poplar Creek to the Elgin Corp. limits,
thence north, west and southwest following the Elgin Corp. limits to Chaparral Cir.,
thence west to Chaparral Ct.,
thence north to the Poplar Creek,
thence northeast following the Poplar Creek to Shales Pky.,
thence northwest to Bode Rd.,
thence east to Brittany Trl.,
thence north and northeast following Brittany Trl. to Eliot Trl.,
thence northwest and north following Eliot Trl. to Brittany Trl.,
thence southeast to Ginger Ln.,
thence northeast to Berner Dr.,

thence northwest to Dale Dr.,
thence southwest to the Hoffman Estates Corp. limits,
thence south, west and north following the Hoffman Estates Corp. limits to Shoe Factory Rd.,
thence west approximately 192 feet following Shoe Factory Rd. to the district boundary,
thence northwest approximately 9,803 feet following the district boundary to I-90,
thence east following I-90 to the Hoffman Estates Corp. limits,
thence north to the Hanover Twp. line (Columbine Blvd.),
thence east to West Central Rd. (Schaumburg Twp.),
thence east to the place of beginning.
