

Representative District 98 shall include that part of Illinois beginning at the Northwest corner of Virden Twp. in Macoupin County,
thence east to the Montgomery County line,
thence east following the Montgomery County line to the South Fork Twp. line in Christian County,
thence north, east, north, east, south, east, south, east, south, west, south and east following the South Fork Twp. line to the Taylorville Twp. line,
thence east and south following the Taylorville Twp. line to Lincoln Trl.,
thence northwest to the Flat Branch,
thence southwest following the Flat Branch to the Taylorville Corp. limits,
thence east, southeast and east following the Taylorville Corp. limits to the Taylorville Twp. line,
thence south to Ridge Ave. (May Twp.),
thence generally east following Ridge Ave. to Lakeside Dr.,
thence southwest, south and southwest following Lakeside Dr. to the Taylorville Twp. line,
thence southwest, southeast and south following the Taylorville Twp. line to Kennedy Rd.,
thence west and southwest following Kennedy Rd. to Lakeview Rd.,
thence southeast to the Taylorville Corp. limits,
thence southwest and generally northwest following the Taylorville Corp. limits to Kennedy Rd.,
thence southwest to Il. Rt. 29,
thence southeast following Il. Rt. 29 to the May Twp. line,
thence north following the May Twp. to the Bertinetti Lake,
thence generally northeast following the Bertinetti Lake to Manor Ct.,
thence south to Lake Dr.,
thence west and southwest following Lake Dr. to the Taylorville Corp. limits,
thence west and south following the Taylorville Corp. limits to Il. Rt. 29,
thence southeast following Il. Rt. 29 to the Locust Twp. line (East 1200 North Rd.),
thence east to the Assumption Twp. line (North 2100 East Rd.),
thence north, east (East 1500 North Rd.) and south (North 2700 East Rd.) to the Pana Twp. line,
thence south, east and south following the Pana Twp. line to the Oconee Twp. line in Shelby County,
thence south to the Ramsey Twp. line (County Rd. 1200) in Fayette County,
thence south following the Ramsey Twp. line to County Rd. 2500,
thence west to County Rd. 1100,
thence south approximately 1,905 feet following County Rd. 1100 to the district boundary,
thence west approximately 3,604 feet following the district boundary,
thence north approximately 1,793 feet following the district boundary to County Rd. 2500,
thence west to County Rd. 2525,
thence northwest, north, northwest and west following County Rd. 2525 to US Hwy. 51,
thence south following US Hwy. 51 to County Hwy. 9,

thence west to the South Hurricane Twp. line,
thence west to the Montgomery County line (South Fillmore Twp.),
thence south, west, south and west following the Montgomery County line to the New Douglas Twp. line in Madison County,
thence south and west following the New Douglas Twp. line to the Olive Twp. line (Brandt Rd.),
thence west and north (Albrecht Rd.) following the Olive Twp. line to the Dorchester Twp. line in Macoupin County (County Line Rd.),
thence west to the Bunker Hill Twp. line,
thence west to the Brighton Twp. line,
thence west and north (Jugtown Rd.) following the Brighton Twp. line to the Brighton Corp. limits,
thence east to Tiffany Ln.,
thence north to South School St. extended,
thence east following South School St. extended to South Park,
thence north to Park Dr.,
thence west to South Main St.,
thence north to Brown St.,
thence east to School St.,
thence north to East Center St.,
thence east approximately 1,220 feet following East Center St. to the district boundary,
thence north approximately 2,810 feet following the district boundary to East Vine St.,
thence west to North Main St.,
thence north to Moore St.,
thence east to the Illinois Central RR,
thence northeast following the Illinois Central RR to the Brighton Corp. limits,
thence south approximately 1,101 feet following the Brighton Corp. limits,
thence east approximately 3,817 feet following the Brighton Corp. limits,
thence south approximately 2,509 feet following the Brighton Corp. limits,
thence east approximately 4,103 feet following the Brighton Corp. limits,
thence south approximately 1,775 feet following the Brighton Corp. limits to the district boundary,
thence east approximately 39,593 feet following the district boundary,
thence north approximately 26,095 feet following the district boundary to the Honeycut Branch,
thence northeast following the Honeycut Branch to Miles Station Rd.,
thence west approximately 1,164 feet following Miles Station Rd. to the district boundary,
thence north approximately 15,977 feet following the district boundary to the Shipman Twp. line (Bachman Rd.),
thence west to Beacon Rd.,
thence north to the Shipman Twp. line,
thence east to the Hillyard Twp. line,
thence east to the Gillespie Twp. line,
thence east to the Cahokia Twp. line,
thence east to the Montgomery County line (North Litchfield Twp.),

thence north to the Shaws Point Twp. line in Macoupin County (Barnett Rd.),
thence west to the Carlinville Twp. line,
thence west, north and east following the Carlinville Twp. line to the Nilwood Twp. line
(Henderson Rd.),
thence north to the Girard Twp. line,
thence north to the Virden Twp. line,
thence north to the place of beginning.
